

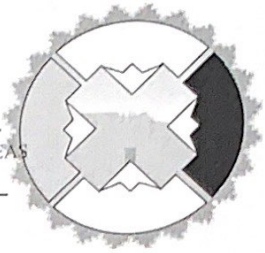

Renter hereby assumes all liability for the cost of repairing or replacing any damaged piece of the Little Sister Rug. If the Rug becomes lost or stolen, Chilchinbeto Chapter will charge Renter by invoice and renter agrees to pay for the lost or stolen item. Upon completion of this Agreement, Renter shall voluntarily surrender the Little Sister Rug to Chilchinbeto Chapter in the same condition as it was when received by the Renter.

Renter acknowledges and agrees that Chilchinbeto Chapter is not liable for any personal injury or property damage during installation, use, and/or removal of the Little Sister Rug.
