He suggests a Resolution to put a legislation in put on behalf of the Union Workers who are employed with Peabody. NGS, APS, SRP continues to buy coal. Mr. Brown will make a report at the Regular Chapter Meeting on January 14, 2018.
- B. Chapter Manager: Evelyna Gray reports there is approximately \$600 in Chapter Scholarship Fund. There is not enough for applicants who are requesting Scholarship fund from the Chapter. UFB allocates \$32 Million and \$3Million is allocated for Navajo Nation Scholarship and \$2,700 is allocated for Chapter Scholarship. However, there is not enough money for Scholarship applicants. Chapter Scholarship Funds are depleted. Recommendation is made by Chapter Vice-President to do fund raising (basketball tournament, pow-wow, request donations, etc. to assist applicants. Fund-raising for Chapter Scholarship remains in discussion. Chapter Scholarship Deadline is February 28, 2018.
